WHEREAS a School, called the Shri Baldevdas Kikani Gujarati Vidya Mandir has been in existence at Syrian Church Road, Coimbatore, for the purpose of imparting education to the children of the residents of Coimbatore; AND WHEREAS the said School is maintained and run by the said Shri Coimbatore Gujarati Samaj; AND WHEREAS by a Special Resolution passed by the Authors of the Trust in their Extra-ordinary General Body Meeting held on Sunday, 3-10-1954, it was resolved to found and create a Trust called "SHREE BALDEVSDAS KIKANI VIDYA MANDIR TRUST", AND WHEREAS the Authors of the Trust have been authorised on behalf of Shree Coimbatore Gujarati Samaj to create the said Trust, and to sign and execute the Trust Deed; AND WHEREAS the President and the Secretary of the said Samaj have been empowered to cause the registration of the said Trust Deed; AND WHEREAS the Authors of the Trust have indicated in their aforesaid Resolution dated 3-10-1954, that the Trust Deed be made out as per the Draft contained in the aforesaid Resolution; WITNESSETH AS FOLLOWS:—

(1) The Authors of the Trust hereby transfer to the Board of Trustees all the monies described in the Schedule hereunder.

(2) The name of this Trust shall be Shree Baldevdas Kikani Vidya Mandir Trust, Coimbatore. (Founded by Shree Coimbatore Gujarati Samaj)

(3) The object of this Trust is to maintain, expand, extend, advance and improve the School run in the name of Shree Baldevdas Kikani Vidya Mandir, Coimbatore.

(4) In the aforesaid School, education will be imparted in the Gujarathi, English, Tamil and Hindi Languages to boys and girls without distinction of caste (and) community.

#### PROPERTY OF THE TRUST

(5) To begin with, the sum of Rs. 58,640-9-0 which is at the credit of Shri Baldevdas Kikani Vidya Mandir (in the hands of the Samaj) and the sum of Rs. 25,000/- announced as donation by Sheth Shri Kishandas Kikani and the sum of Rs. 22,222/- announced as donation by Sheth Shri Gokuldas Thulsidas Raichura, in all amounting to Rs. 1,05,862-9-0 shall be deemed as the property of the Trust. Further, whatever is possible shall be collected out of the outstandings in connection with the Drama "Sarvodaya" enacted for the benefit of Shri Baldevdas Kikani Vidya Mandir and added on to the property of the Trust.

#### BOARD OF TRUSTEES

(6) The Board of Trustees of Sri Baldevdas Kikani Vidya Mandir Trust, will consist of five members in which

- (1) Shri Kishandas M. Kikani will be Hereditary Trustee,
- (2) Shri Gokuldas Thulsidas Raichura, will be a Life-Trustee,
- (3) One Educationist will be taken in as a Trustee without distinction of caste or community, and
- (4) The remaining two Trustees will be elected from among the members of the Samaj.

(7) The appointment of the Managing Trustee, will be made by the Board of Trustees out of the four Trustees of the Samaj only. Barring the hereditary and the Life Trustees, the term of Office of the rest of the Trustees will be for Three years.

(8) The hereditary (Trustee) and the Life Trustee will continue to be the members of the Shree Coimbatore Gujarati Samaj.

(9) No one, who is not a member of Shree Coimbatore Gujarati Samaj or whose name is not found in the Register of the Samaj for two continuous years before election, can be elected as a member of the Board of Trustees. This clause shall not apply in the case of the Educationist Trustee).

(10) Any sudden vacancy caused in the Board of Trustees, shall be filled up by a General Election out of the General Body members of Shree Coimbatore Gujarati Samaj within a month of such vacancy. Such an elected Trustee shall hold office only for the un-expired portion of the tenure.

(11) Any one of unsound mind (or) a leper, (or) of contagious disease (or) punished for any of the acts of immorality or adjudicated as an insolvent, shall not remain in office as a Trustee.

(12) An elected Trustee, who abstains from three (3) consecutive meetings without obtaining prior permission shall lose the Office of his Trusteeship.

#### POWERS OF THE BOARD OF TRUSTEES

(13) Movable and immovable property of the Trust shall be deemed to belong to the Trust Board. They shall have authority over the cash and properties of the Trust. Likewise they shall have the right to purchase land, cause the construction of buildings for it, and effect sales.

(14) The Board of Trustees shall have the full powers vested in it to maintain, run and supervise institutions.

(15) The Board of Trustees shall meet at least once in two months.

(16) It shall be within the absolute powers of the Board of Trustees to maintain proper accounts of receipts and disbursements and arrange to have the said accounts audited. The Board of Trustees will approve the budget for (each) year.

(17) In the Board, decision by a majority of Trustees, will be deemed as the decision of the Board.

(18) No meeting of the Board of Trustees shall be conducted unless and until at least three Trustees are present. The quorum for the meeting of the Board of Trustees will therefore be three.

(19) At every meeting of the Board of Trustees, a Trustee other than the Managing Trustee, shall be elected as the Chairman.

(20) In the Meeting of the Board of Trustees, if there is any tie of votes regarding any resolution, the Chairman of the meeting shall exercise his personal vote (casting vote).

## FINANCIAL MATTERS OF THE TRUST

(21) The surplus monies of the Trust shall be deposited in the Imperial Bank of India, Coimbatore, in the United Commercial Bank Ltd., or in the Central Bank of India Ltd., or in the Securities approved by the Government, to the credit of Shri Baldevdas Kikani Vidya-Mandir Trust.

(22) Out of the three Trustees including the Managing Trustees, any two Trustees will be empowered to operate the accounts in accordance with the resolution of the Board (The Educationist Trustee shall not have this power).

(23) Any two Trustees chosen by the Board of Trustees out of the aforesaid Panel of three (3) Trustees, shall draw, sign and encash cheques and Hundies.

(24) The undermentioned powers approved by the Board of Trustees shall be enjoyed by the Managing Trustee:—

- (i) To take such steps as are necessary for the management, conduct and administration in regard to the School;
- (ii) To appoint the salaried staff, teachers and workmen on the terms decided upon by the Board of Trustees for the conduct of the School.
- (iii) To suspend, fine, or dismiss such salaried staff.
- (iv) To lay down regulations in the matter of admission and removal of the students in the school.
- (v) To correspond with the Government, private and Public Bodies in respect of the School or in respect of other matters.
- (vi) To carry out the resolutions of the Board, to sign letters (papers) receipts and documents, receive and pay monies, accept cheques and bills, promissory notes, Hundies or other negotiable instruments, and take steps, in legal matters, to institute, conduct and defend cases.

(25) If the Managing Trustee finds it necessary, or if two or more Trustees of the Board of Trustees demand in writing, the Managing Trustee will have to call for a meeting of the Board of Trustees within one week of such written requisition. The managing Trustee will send notices to the Trustees to their residence and addresses at least three days prior to the date of the calling of such meeting.

(26) The Managing Trustees will be responsible for the important records (papers) account books, documents and all the property of the Trust and (the) institution run under its auspices.

(28) Under each head of account for expenses over and above the budget approved for that (particular) year, the Managing Trustee shall have the power to apply for additional monies.

(29) Every year, the Managing Trustee shall, on behalf of the Board of Trustees, present before the members of Shri Coimbatore Gujarati Samaj (the Authors of the Trust) an audited statement of accounts.

(30) The Board of Trustees will be authorised to appoint a School Committee whenever it thinks fit and necessary.

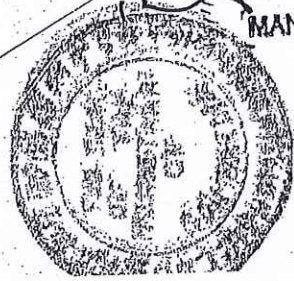
